

Important Information

- 1. Students must read the Prospectus carefully before filling in the Admission form.
- 2. The college administration shall not be responsible for any mistake made by the students in the Admission Form and upon subsequent rejection by the Selection Committee. If admission is done with incorrect data, it may be cancelled by the College/ University Authority at any stage.
- 3. Ragging of students in any form is a punishable offence as per the direction of Supreme Court of India.
- 4. Subject combination/subject cannot be changed after admission.
- 5. The college being a Private college is governed by the rules and regulations of Arunachal Pradesh Govt. in its administrative matters and its Academic matters are governed by the rules of the affiliating University- Rajiv Gandhi University, Itanagar.
- 6.Students who are absent without giving leave application one day before to the Principal is considered as irregular and fine Rs. 50/- will be imposed after observing the situation.
- 7. All academic affairs of the students such as individual behavior, percentage of class attendance, subject completion by the teachers, monthly assessment test record will be intimated to the parents/guardians through Mobile SMS in the weekends.
- 8.75% attendance is compulsory for all the students in each semester. 5% shortage will be condoned in case of serious health problems of the students after due certification from the authorized Medical Officer. Students having less than 75% but more than 60% attendance in each end-semester without genuine reason will be declared non-collegiate and he/she will have to pay a fine of ₹ 500/-, 59-50: ₹ 1,000/-, 40-49 %: ₹ 1,500/-. Students with less than 40% attendance will be declared as dis-collegiate and he/she will not be allowed to appear in the end-semester exam.



COLLEGE FACILITIES

The college always strives to offer optimum facilities to the students out of its limited resources. Students are to use these facilities judiciously and properly without giving any scope for misuse or wastage.

COMPUTER LAB & INTERNET

The computer lab and internet services has been established in the college premise and is accessible to all registered students and faculties of the Institute during college hours. The lab is equipped with computers with the latest software necessary for your academic needs. High-speed internet connectivity is provided in the computer lab. The College also offers a 12 (Twelve) month Certificate Course in Computer Education, Diploma in Computer Applications (DCA) to enhance the learning of the students free of cost for all the registered students of the college. For more details you may contact the office.

LIBRARY AND READING ROOM

The college library has sufficient text books and reference books for the students and teachers. The library has a separate reference section. It subscribes several dailies, weeklies and monthly magazines. Suitable arrangements have been made for the students to read them during leisure hours. Students can borrow the books from the library with the help of



their library card which will be issued at the time of admission. Students are entitled to get a maximum of two books issued for fifteen days against each library card. A fine ② ₹ 2/- per day shall be imposed after the expiry of the date of the returning of the books.



CONTACT WITH GUARDIAN

The guardian will regularly be informed of the academic progress, class attendance and conduct of their wards. The college has a parents body which sits 2/3 in year to recommend suggestions for better future of students and the college as whole.

STUDENTS CHARITABLE FUND

In the history of Arunachal Pradesh, the first ever system of charitable fund has been introduced at Mahabodhi Lord Buddha College for uplifting of the poor as well as meritorious students. The Students Charitable Fund are being donated by the teaching & non-teaching staffs of the college from their monthly salary. The students who belong to poor background will be supported financially from this fund. Meritorious students will also get financial help from this fund. The procedure of the selection of meritorious students will be based on the entrance exam conducted by the College Authority. At least one student from poor background and one meritorious student respectively, will be awarded financial help from this fund. The number of students will be enhanced as per the allocation of fund.

CONVEYANCE FACILITY

The college is also providing bus for the conveyance of students & staffs to & fro college and to avail these service one has to pay a minimal fee of ₹ 3,000/- per semester.

STIPEND

All APST students are entitled to receive stipend after scrutiny of their monthly attendance by the Attendance Monitoring cell of the Directorate of Higher & Technical Education, Government of Arunachal Pradesh.

Conditions for grant of stipend-

- The grant of stipend depends upon the satisfactory progress and good conduct of the students. If the stipendiary are found guilty of misconduct such as restoring to or participating in strikes, irregularity in attendance withhold the permission of the Principal and if they commit any major offence or breach the college discipline. the Principal has the power to suspend the award of stipend with approval from the College Management Committee.
- The Government shall have the inherent right to cancel the stipend wholly or partly or stop or withhold further payment for any reason which the Government thinks proper.
- If a student is found to have obtained stipend by any false means, the stipend paid will be recovered and such students will be black-listed and deterred from getting benefits under any a scheme forever.
- The stipend awarded may be cancelled if a student changes the subject of the course of study for which the stipend was originally awarded or changes the institution of study without the prior approval of the Government of Arunachal Pradesh.
- A stipendiary shall ceases to withdraw stipend as and when he gets a government job.
- Disbursement of stipend will be subjected to regular attendance in the college and satisfactory academic performance and general behavior inside and outside the college campus. At least 85% classes must be attended in every month so as to get the stipend. Attendance report of every student has to be sent to the Director of Higher & Technical Education, Itanagar (Stipend Granting Authority) every month.

ISHAN UDAY SCHOLARSHIP

The UGC under union Minister of Human Resource Development has launched a Special Scholarship Scheme ISHAN UDAY for North-East Region from the academic year 2014-15 onward for the meritorious students of lower economic strata.

CAREER COUNSELING PROGRAM

Special coaching for weak students will be conducted to encourage students for better academic performance.






CULTURAL AND LITERARY ACTIVITIES

ADMISSION RULES & REGULATIONS

Admission rules

- 1. Students who have passed their intermediate (Class XII) under any state or central Govt. Education Boards or any equivalent examination are eligible for admission.
- 2. All admissions are provisional and shall be further approved by the Affiliated University.
- 3. Students who have migrated from other University jurisdiction need to pay eligibility fee at the time of admission.

Requirements and procedures for admission

- 1. Eligible candidates should submit the duly filled applications before the last date as notified on the college notice board.
- 2. Copies of the necessary documents duly attested by a Gazetted officer should accompany the application.
- 3. The selection list will be notified based on the rules of merit and roaster as prescribed by the Government and the University.
- 4. Students should attach the caste certificates wherever necessary to claim reservation under different categories.
- 5. The prescribed fees should be paid during the time of admission.
- 6. Request regarding change of combination will not be entertained after admission.
- 7. Original Mark Sheet, Caste Certificate and TC should be produced at the time of admission for verification.

Documents to be produced at the time of admission

- 1. Attested copy of 10+2 Mark-sheet.
- 2. Attested copy of class 10 Mark-sheet.
- 3. Attested copy of Caste/ Income Certificate (to claim reservation)

Documents to be attached with application form

- 1. Original class 10+2 Mark-sheet
- 2.Original TC or TC memo
- 3. Original Character Certificate
- 4. Passport size photographs
- 5. Original Caste / Income Certificate
- 6. Migration Certificate in case of students coming from other universities jurisdiction

Note: Candidates are advised to make copies of the original testimonials (certificates, mark sheet, TC, caste, income certificate) as they cannot be returned to them until their admission is approved by the University.



Attendance

75% attendance is compulsory for all the students. 5% shortage will be condoned in case of serious health problems of the students after due certification from the authorized Medical Officer.

Examination fees for each semester

The admitted candidates have to deposit the examination fees separately as and when notified by the Principal of the college before the commencement of the practicum activities and filling up examination form i.e. prerequisite for each semester examination. A student has to deposit the examination fees amount (As notified in the Notice Board) separately on the day of filling the examination form for each semester examination as per the rule enforced from time-to-time.

Instruction for filling the Application Form

Application form is enclosed along with the prospectus and we request you to go through the following points and fill the application form carefully.

- 1. The candidates name is entered while you are receiving the form from the office.

 Any alternation in the name recorded in the form leads to rejection of the form.
- 2. Date of birth has to be entered in DD/MM/YYYY format.
- 3. Mention your tribe / caste name.
- 4. Write both your father's name and mother's name. if you are in the care of a guardian, then write your guardian's name.
- 5. Occupation and annual income of parents has to be written. If parents are not alive, then guardian's income and occupation has to be written.
- 6. Clearly write your permanent and correspondence address. If both are same, then mention it clearly.
- 7. Write the institution where you have studied class XII.
- 8. The medium which you passed your class XII.
- 9. Clearly indicate the combination you have chosen.



- 10. If you have received any distinction in sports and extracurricular activities, attach the attested certificates along with the application form.
- 11. Name of the village / town, the candidate and parents belong to.
- 12. Name of the language group the candidates belongs to (i.e. Assamese, Bengali, Punjabi etc.).
- 13. Religion (Buddhism, Hinduism, Islam, Christianity, Sikhism, Jainism etc.).
- 14. Nationality of the candidate.

Some Important University Rules (for Semester System)

- 1.A student who has less than 75% attendance shall not be permitted to sit for the end semester examination in the course in which shortfall exists.
- 2. Provided that it shall be open to the University to grant exception to a student who has attended minimum of 60% classes but fail to obtain the prescribed 75% attendance for valid reasons on recommendation of the Head/Director of the centre on payment of a prescribed fee(s).
- 3. Examination and evaluation shall be done on a continuous basis.
- 4. There shall be 20% marks for internal assessment and 80% marks for end semester examination in each course during every semester.
- 5. There shall be no provision for re-evaluation of the answer scripts of the end semester examinations. However a candidate may apply for re-checking.
- 6. A candidate shall be declared as passed a course provided he/she secured:
- At least 35% marks in the course and 40% in the aggregate in the semester examinations.
- At least 40% marks in the sessional / internal examination (in semester) and 40% at the end semester examinations separately.
- 7.A student must pass all his / her semester examinations within 7 (Seven) years from the date of admission to the first semester of any program or late college candidate in any program in this system.
- 8. Since the semester system involves continuous assessment, there shall be no scope for student to appear as private.



DISTANCE EDUCATION





Rajiv Gandhi University (RGU) is a central university located in Arunachal Pradesh, India. 

Ed. course for teachers training education was introduced from 2017-18 academic session onwards to bring Excellency and Proficiency in the line. It is our sincere effort to make ourself, one of the premier institutions in the whole of Arunachal Pradesh in offering higher education.

Recognition

Mahabodhi Lord Buddha B.Ed. College is offering 2 (Two) years B.Ed. course affiliated to Rajiv Gandhi University, Itanagar, Arunachal Pradesh and is duly recognized by the National Council of Teacher Education (NCTE) and approved by the State Govt. Of Arunachal Pradesh, Department of Higher Education. The college promotes innovative works and research in the field of teacher education by introducing action researches, work-experience activities, seminars, indigenous teaching learning materials and by conducting rigorous skill based teaching and training program, etc.to bring behavioral change in Teacher-Trainees in particular and upgrading of teacher education in general.

Program Objectives

The program aims to enable teachers in achieving the following objectives.

- 1.To systematize experience and strengthen the professional competencies of teachers.
- 2. To imbibe knowledge and develop an understanding of the various methods and approaches of organizing learning experience of secondary school students.
- 3. To develop skill required in selecting and organizing learning experiences.
- 4. To understand the nature of the learning process.
- 5. To develop skills involved in dealing with the academic and personal problem of learners.
- 6.To acquire knowledge and develop an understanding of various aspects of school management.
- 7.To develop competencies for organizing various instructional and student support activities.
- 8.To develop an appreciation of the role of the teacher in the prevailing socioculture and political system in general and the educational system in particular.
- 9. To develop skills involved in selecting, developing and evaluating tools.



Information about Admission

The college follows the semester system in B.Ed. course with a component of continued evaluation for bringing qualitative improvement in teaching-learning process. The course is of 2 (Two) year duration spreading over four semesters. Admission to the course will be done at the beginning of each semester, unless decided otherwise by the Academic Council of the Affiliated University.

The prospectus of the college containing application form for admission may be obtained from college office/counter and the duly filled in forms with self attested copies (in duplicates) of the required document as mention in the application form have to be submitted in the office/counter.

Intake capacity

The intake capacity of the college for the current academic session is 100 (One Hundred) as per the permission granted from NCTE.

Eligibility

Candidate with BA/B.COM/B.Sc. degree from Rajiv Gandhi University or any other recognized university with at least 50% marks in graduation degree under (10+2+3) pattern/scheme is eligible for the admission in B.Ed. course. SC/ST candidates shall be given a relaxation of 5% marks. PG holders are also eligible for the course and will be given preference as per the guidelines of RGU.

Reservation

60% of seats in total will be reserved for ST candidates, 9% for OBC, 3% for SC, 5% for wards of ex-service men, 3% for specially-abled and 20% for general candidates. However, if there are no OBC, SC, General and specially-abled applications, etc. the seats will go to ST category and if ST candidates are not available then seats will be treated as general. One seat will be reserved as sports quota out of general quota. The outstanding sports men/sports women will be given 10% weightage for representing the country at the international level, 5% for representing the state at the national level and 3% for inter-university at national level and shall be added as weightage to marks obtained at qualifying exams. However, the candidates applying under the sports quota will have to satisfy the minimum percentage of marks prescribed to be eligible for the seats reserved for general category.



For NSS volunteer, a weightage of 5 (Five) marks will be given for (i) 240 hours of social service and 2 (Two) special camps/ 1 (One)NIC (National Integration Camp)/RDC Delhi (Republic Day Camp) and weightage of 3 (Three) marks for (ii) 120 hours of social service/ 1 (One) special camp. For NCC cadet, weightage of 5 (Five)and 3 (Three) marks will be given for C and B certificate holders respectively.

Admission Procedure

The admission in B.Ed. course shall be made purely on MERIT basis, of marks obtained in the qualifying examination or any other selection process/ criteria enforced by the College Authority and RGU time-to-time.

Selection Procedure

Actual admission shall be based on merit in accordance to the following criteria:

- 1. Percentage of marks in graduation (10+2+3) with additional weightage as under:
- 2% marks for honours in any subjects• 2% marks will be given to those who hold master degree at the time of submission of application.
- 10% marks for graduates from Rajiv Gandhi University or 5% marks for APST graduate from other universities.
- 2. Order of merit shall be determined after giving weightage to the above points. However, distribution of seats to candidates from different streams/ subject will be taken into consideration as far as practicable.
- 3. The admission will be only in one phase and the candidates seeking admission should apply for admission on or before the date.

Admission Rules

- Students who have passed their graduation or post graduation under any recognized college/institution/universities are eligible for admission.
- All admissions are provisional until approved by the university.
- Students will be given admission according to merit basis for limited seats.

Requirements and Procedures for Admission

- Eligible candidates should submit the duly filled applications before the last date as notified on the college notice board & prospectus.
- Copies of the necessary documents duly attested by self should accompany the application.
- The selection list will be notified based on the rules of merit and roaster as prescribed by the government and the university.
- Students should attach the caste/ sports/ NSS/ NCC Certificates wherever necessary to claim reservation under different categories.
- The prescribed fees should be paid during the time of admission.
- Original marks sheet, caste certificate and TC should be produced at the time of admission for verification.

There will be separate notification regarding the registration process and its requirements for the students who have completed their graduation/qualification degree from any other university apart form the affiliating university i.e. Rajiv Gandhi University.

For internship the school given by the DDSE Namsai and College administration to the concern teacher trainee will be final.



General Information about Examination

- 1. The college follows semester system for the two years B.Ed program with a component of continuous and comprehensive evaluation for bringing qualitative improvement in the teaching learning process.
- 2. There shall be 21 papers (including four practical and field experience paper of 50 marks and 100 marks) of 100 marks each in the course. The course shall be evaluated in two parts i.e. internal assessment part of 25 % and semester-end examination for 75% marks for each paper. In addition there shall be teaching practice and viva-voice examination which shall be evaluated in terms of grades.
- 3.A student must attend a minimum of 75% of lectures, tutorials, seminars etc. organized by the Institution during each semester of the academic year to be eligible to appear in the examination.
- 4. The internal assessment shall be based on term paper, seminar paper, assignments, tutorials, internal written examination/assessment and participation in community work etc. There shall be three internal assessments (IA) for each course in a semester. The marks obtained in the best two, out of the three internal assessment shall be out of 25 marks and assignment and seminar presentation shall be out of 10 marks. This shall be normalized to maximum 25 marks fir consideration towards internal assessment.
- 5.A student must obtain a minimum of 40% marks in at least two sessional assessments in each theory paper in a semester and attend 75% of lectures and tutorials, to qualify for appearing in the semester-end examination, failing which he/she shall not be allowed to fill-up the examination form. In case of practical oriented subjects or papers, a student also has to secure 40% marks in the practical sessional assessments.
- 6.A candidate shall apply for admission to an examination in the prescribed form to the Head of the Institution. Such application shall be accompanied by a certificate indicating that (i) the candidate had attended the minimum number of lectures, etc. in respect of all courses, (ii) the candidate had cleared the sessional works, if any, and (iii) all dues including prescribed examination fees have been deposited.
- 7.In order to pass the examination, a candidate must secure a minimum of 40% marks in internal assessment/ sessional work and 40% marks in each paper in semester end examination separately. The aggregate percentage required for passing the examination in each semester is 45%.
- 8. Those securing 45% and above but less than 60% will be placed as second class and those securing 60% and above will be in the first class.
- 9. In case of improvement, the division will be awarded on the basis of the total marks secured following the improvement in the existing rules of improvement.



- 10. A student shall be allowed to move from one semester to the next semester, if he/she clears at least three theory courses/ papers with 45% aggregate in the qualifying theory papers and teaching practice & viva-voce examination with a minimum of C grade in the end semester examination of the first semester.
- 11. The practice teaching and viva voice will be evaluated in terms of grades having following equivalent marks:
 - Outstanding : O above 75% marks
 - Very Good : A 65% to 74.99% marks
 - Good : B 55% to 64.99% marks
 - Average : C 45% to 54.99% marks
 - Fail: D below 45% marks
- 12. A candidate who is unable to clear (i) internal assessments in each theory paper, (ii) practice teaching and viva- voice examination, and/or (iii) unable to pass in minimum three papers with requisite aggregate percentage of marks/ grade (i.e. 45%) in qualifying papers in the first semester shall be out of the program and would require to seek fresh admission as per admission criteria in force from time to time.
- 13. For regular students the duration of end-semester examination shall be three(03) hours.
- 14. The medium of instruction and examination in the study program shall be English & Hindi only.
- 15. The college may cancel admission/examination of a candidate, if it is found that he/she is not eligible for admission/ to appear in the examination and has obtained admission through misrepresentation or a concealment of fact.

Examination Centre

Centre of examination shall be Mahabodhi Lord Buddha B.Ed. College, Adi Ningroo, Namsai, Arunachal Pradesh.

Examination Fees per Semester

The admitted candidates have to deposit the examination fees separately as and when notified by the Principal of the college before the commencement of the practicum activities and filling up examination form i.e. prerequisite for each semester examination. A student has to deposit the examination fees amount (As notified in the Notice Board) separately on the day of filling the examination form for each-semester examination as per the rule in force from time-to-time.

Code of Conduct for Students

On admission to any course of study, every student submits himself/herself to disciplinary jurisdiction of the management of the college, the in-charge and other officers of the college who may be vested with the authority to exercise discipline. Students also submits to the following code of conduct for students and also to any rules framed at a later date.

- 1. Students should follow the time table scrupulously and make best use of the facilities.
- 2. Use computer lab, library and sports facilities with great care and concern.
- 3. Participate in sports, cultural, meditation and literary events with full interest and zeal.
- 4. Make note of announcements made on the notice board regularly.
- 5. Safeguard the Identity Card and Library Card carefully.
- 6. Follow discipline, maintain peace and behave respectfully in the college premises.
- 7. The use of mobile phones in the class rooms and college premises is strictly prohibited.
- 8. Students should maintain cleanliness in the college and show concern for the environment.
- 9. Electrical appliances such as computers, lights, fans, etc should be switched off after use.
- 10. Industrial visit is compulsory for the commerce students.
- 11. DRESS CODE: Wearing uniform is compulsory for all. For more information about dress code, contact college office.
- 12. Students should go through the following rules and regulation regarding Code of Conduct for students and keep themselves aware of the college rules. Ignorance of rules shall not be an excuse for violation. Each student shall conduct herself/ himself, both within and outside the campus of the institute in a manner befitting a student of a prestigious institution.
- Each student shall show due respect and courtesy to the teachers, administrators, staff of the college, and to the visitors and residents of the college and good behavior to fellow students.
- Lack of courtesy and decorum; unbecoming conduct within and outside the college; willful damage to college property, removal of any property belonging to the college, fellow students or other personal and residents of the college; use of abusive and offensive language: disturbing fellow students in their studies; breach of rules and regulations of the college; adoption of unfair practices in tests, quizzes, assignments, or examinations; noisy and unruly behavior shall constitute violation of the code of conduct.
- Loud talking, loitering or congregating, being a source of distraction and annoyance to others is not permitted.



- Students are required to be dress neatly and decently.
- Use of cell phones is strictly prohibited in all areas of campus.
- Use of cell phones would entail confiscation of the handset. It would be returned only (a) at the end of the course or (b) after payment of a fine of Rs. 1000/-.
- Late arrival and early departure at or from a class are recorded as absence from the class.
- Students are not allowed to leave the college during working hours without the written permission of the principal.
- Students will not operate any machinery/equipment without the permission of the instructor.
- No responsibility will be accepted by the college for any injury, loss or damage to the personal articles of students.
- The students at the college require attention and diligence. A student neglecting his/ her studies and having unsatisfactory progress will be given two warnings after which if he/she fails to improve, he/ she will be liable for expulsion from the college.
- It is compulsory for the students to attend functions/ activities organized by the college on various occasions like Independence day, Republic Day, Annual Day, etc. Whether the function fails on a working day or on holidays. Absence from such functions without valid reasons will invite disciplinary action.
- Students shall observe all safety precautions. The college is not responsible for any accident, of whatever nature, in the college, hostel, workshop, play ground and during summer training or educational tour/ trip.
- Students are prohibited to take part in ragging, political activity or any activity which is detrimental to the dignity of the college. Any student found violating the rule or bringing disrepute to the institution will be expelled from the institute.
- The students will compensate damage to institute/ hostel property/ furniture caused by neglect or willful damage. Defacing the walls or college property will be viewed seriously.
- Students must make all possible efforts to conserve electricity and water. They
 must switch off lights & fans when they leave the class room/ hostel room, lab
 etc. Students must help keep the college neat and clean and also preserve and
 maintain the gardens.
- Students must pay their fee/ dues on or before the prescribed deadline failing which appropriate disciplinary action will be taken. Students may note that fees once paid will not be refunded/adjusted. If student leaves the course before completion, he/she will be required to pay the fee for the entire course.
- Students must keep their identity cards always with them and shall show the same on demand by any faculty/official of the college.



- Candidates have to fulfill the minimum attendance requirements as per university norms. No students will absent himself/herself from any of the lectures without leave having been obtained previously from the Class In-charge and that too for sufficient cause and if he/she is irregular in attendance, or fails to show progress or is not diligent in studies, his/ her name is liable to be struck off from the rolls of the Institute. In case of a candidate who joined late owing to late declaration of result or who sought admission provisionally till declaration of the lower examination, the lecture requirements will be calculated as per academic rules and provisions given by the university.
- Students claiming benefits / concessions on medical grounds are required to submit medical certificate from a Govt. Hospital or Dispensary.
- The name of the student who fails to submit the University examination form for the semester in which he/ she is studying without the approval of the principal shall be removed from the College rolls.
- The students are advised to see regularly the notices displayed on the college on the college notice boards. The notice displayed on these notice boards shall be deemed to have been served on the students.
- Any students who fails to clear all the dues shall be declined from appearing in semester examination.
- All applications must be addressed to the Principal.
- The Director/Principal reserves the right to modify any of the college rules as and when necessary. The decision of the director/ principal in all matters shall be final. Ordinance related to maintenance of discipline among the students of the institute.
- 13. All powers relating to discipline and disciplinary action are vested with the Director / Principal.
- 14. The director/principal may delegate all or such powers as he deems proper to any of the official of the institute. Every member of the staff has authority to forbid disorderly behavior within the institute.
- 15. Without prejudice to the generality of power to enforce discipline under the ordinances, the following shall amount to acts of gross indiscipline:
 - Ragging in any form within premises of the college or surrounding of the college.
 - Physical assault or threat to use physical force against any member of the teaching, non-teaching staff of the institute and against any student within premises of the college or surrounding of the institute.
 - Carrying or threats to use of weapon.
 - Any violation of the rules, regulations, norms promulgated by the university from time to time.
 - Violation of the status, dignity and honor of any student.
 - Any practice, whether verbal or otherwise, derogatory to women.
 - Any attempt to bribery or corruption in any manner.
 - Willful destruction of the college property.
 - Creating ill will or intolerances on religious, tribal, linguistic, communal, political or any ground.



- 16. Without prejudice to the generality of his powers relating to the maintenance of discipline and taking such action in the interest as may deem to him appropriate, The Director may, in exercise of his powers aforesaid, may order or direct.
 - That any student or students be expelled, or
 - Any student or students be, for a stated period, rusticated, or
 - Not allowed to attend a course or courses of study in a department of the institute for a stated period.
 - Be fined.
 - Be debarred from giving a departmental examination or university examination.
 - That the result of the student or students concerned, in the examination or examinations which he/she appeared be withhold or cancelled.
 - That the student be suspended from the institute till completion of pending enquiry.
- 17. At the time of admission, every student shall be required to sign a declaration that, on admission he/she submits himself/herself to the disciplinary jurisdiction of the Director and other Authorities of the college who may be vested with the authority to the exercise discipline under the rules and regulations that have been framed by the college.
- 18. The college authorities shall have authority to exercise all such disciplinary powers over students as they may find necessary, for proper conduct of the college.
- 19. Without prejudice to the powers of the Director, detailed rules of discipline and proper conduct in class rooms/ laboratories/ Institute campus may be supplemented, wherever necessary, by the Head of Departments. Each student shall be expected to study and follow these rules.
- 20. A defaulting student who is aggrieved with the punishment awarded may prefer an appeal to the Chairman of the Institute stating the reasons as to why the punishment should not be awarded. The Chairman shall prescribe the procedure to process such appeals.
 - Any kind of misconduct with the staff of the college by the students will not be tolerated by the management and proper legal action will be taken as per the concerned guideline.

Note: Parents/Guardians are advised not to encourage their wards to remain absent without proper reasons during the academic session. Medical leave will be granted strictly only as per the need approved by the Medical Authority.






